#### **HEALTH INSURANCE - MARKETPLACE COVERAGE**

##### **WHAT IS THE HEALTH INSURANCE MARKETPLACE?**

The Marketplace offers “one-stop shopping” to find and compare private health insurance options. In the marketplace, you could be eligible for a new kind of tax credit that lowers your monthly premiums and cost-sharing reductions (amounts that lower your out-of-pocket costs for deductibles, coinsurance and copayments) right away, and you can see what your premium, deductibles and out-of-pocket costs will be before you make a decision to enroll. Through the Marketplace, you will also learn if you qualify for free or low-cost coverage from Medicaid or the Children’s Health Insurance Program (CHIP). ##### **COBRA CONTINUATION COVERAGE**

If you are enrolled in health insurance coverage through Chemung County and your health insurance coverage is ending due to a qualifying event, you will receive information in the mail regarding your COBRA Continuation Coverage rights and the cost from ebm (ebenefit Marketplace) on behalf of Chemung County. This notice will describe in detail this option available to you.
