WHEREAS, The New York State Department of Transportation (NYSDOT) has been designated by the Governor of the State of New York to administer Public Transportation Modernization and Enhancement Program (MEP) funds for Chemung County transit capital projects; and

WHEREAS, Chemung County has applied for capital funding for rehabilitation of the Chemung County Transportation Center built in 1998 and the purchase of two replacement buses that have met their useful service life; and

WHEREAS, ECTC is the metropolitan planning organization responsible for programming transportation funding for projects in the Elmira urbanized area, and NYSDOT Transit Bureau has requested that NYSDOT Capital Projects be included; and

WHEREAS, the ECTC FFY 2017/18-2021 Transportation Improvement Program (TIP) needs to be amended to change PIN 6821.27.001 from the previous illustrative project to the NYSDOT Public Transportation Modernization and Enhancement Program funds in the amount of \$691,069; and

NOW, THEREFORE, BE IT RESOLVED, that the Elmira Chemung Transportation Council Policy Committee hereby approves revision of the FFY 2017/18-2021 Transportation Improvement Program (TIP) to incorporate these new projects as shown on the attachment which is part of this resolution, and be it further

RESOLVED, that these TIP revisions be forwarded to the various Federal and State agencies as required.
