RESOLUTION AWARDDING BID TO JIM'S EQUIPMENT REPAIR, INC. ON BEHALF OF THE CHEMUNG COUNTY SOIL AND WATER CONSERVATION DISTRICT (RFB-2007 Two new 2018 model continuous four-wheel drive articulating all terrain mowing tractors)

WHEREAS, sealed bids, pursuant to RFB-2007, were received and opened on December 28, 2017 for two new 2018 model continuous four-wheel drive articulating all terrain mowing tractors (the "Equipment"); and

WHEREAS, the Director of Natural Resources on behalf of the Chemung County Soil and Water Conservation District has recommended the acceptance of the lowest responsible bid meeting all bid specifications for the Equipment; and

WHEREAS, the County Executive and the Buildings and Grounds Committee have reviewed the bid specifications, the bids submitted, the recommendations of the Director of Natural Resources, and they all recommend the Chemung County Legislature award the bid to the lowest responsible bidder meeting all bid specifications for the Equipment, i.e., Jim's Equipment Repair, Inc. ("Jim's") for two new 2018 Steiner model 450 continuous four-wheel drive articulating all terrain mowing tractors as more particularly described in the bid submitted by Jim's; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Jim's is the lowest, responsible bidder meeting all bid specifications for the Equipment; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Jim's for the Equipment at a total cost of \$37,189.80 as more specifically set forth in the bid submitted by Jim's; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Jim's shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed, the initial term thereof extended, or the agreement amended without express consent by Resolution of this Legislature.
