RESOLUTION AWARDING BID TO SKYWORKS, LLC ON BEHALF OF THE CHEMUNG
COUNTY DEPARTMENT OF BUILDINGS AND GROUNDS
(RFB-1991 One 2011 or newer sixty-six foot boom lift with trade-in)

WHEREAS, sealed bids, pursuant to RFB-1991, were received and opened on November 22, 2017 for one 2011 or newer sixty-six foot boom lift with trade-in of one 1990 JLG60 HA Platform (the "Equipment"); and

WHEREAS, the Superintendent of Buildings and Grounds has recommended the acceptance of the lowest responsible bid meeting all bid specifications for the Equipment; and

WHEREAS, the County Executive and the Buildings and Grounds Committee have reviewed the bid specifications, the bids submitted, the recommendations of the Superintendent of Buildings and Grounds, and they all recommend the Chemung County Legislature award the bid to the lowest responsible bidder meeting all bid specifications for the Equipment, i.e., Skyworks, LLC, for one 2011 JLG Model 660 SJ SP sixty-six foot boom lift at \$52,500 less \$4,500 for trade-in of one 1990 JLG 60 HA platform for a net cost of \$48,000 as more particularly described in the bid submitted by Skyworks, LLC; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Skyworks, LLC is the lowest, responsible bidder meeting all bid specifications for the Equipment; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Skyworks, LLC for the Equipment at a total net cost of \$48,000 as more specifically set forth in the bid submitted by Skyworks, LLC; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Skyworks, LLC shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed, the initial term thereof extended, or the agreement amended without express consent by Resolution of this Legislature.
