WHEREAS, a sealed proposal, pursuant to RFP-2038, was received and opened on May 17, 2018 on behalf of the Elmira Corning Regional Airport for wildlife hazard management including the development and maintenance of a wildlife hazard management plan consistent with the regulations of the Federal Aviation Administration (collectively the "Services"); and

WHEREAS, the Director of Aviation has reviewed the specifications for the Services and the proposal submitted and he recommends the acceptance of the lowest responsible proposal meeting all specifications for the Services; and

WHEREAS, the County Executive and the Aviation Committee have reviewed the specifications, the proposal submitted, and the recommendation of the Director of Aviation, and they all recommend the Chemung County Legislature accept the proposal submitted by Loomacres Wildlife Management ("Loomacres"), having determined that Loomacres is the lowest responsible provider meeting all specifications for the Services; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Loomacres is the lowest, responsible provider meeting all specifications for the Services; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Loomacres for the Services at a total cost of \$109,057.08 (Year 1 - \$20,541.40, Year 2 - \$21,157.64, Year 3 - \$21,792.37, Year 4 - \$22,446.14, and Year 5 - \$23,119.53) as more specifically set forth in the proposal submitted by Loomacres; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Loomacres shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed, the initial term thereof extended, or the agreement amended without express consent by Resolution of this Legislature.
