(RFB-2044 HRC Building Partial Window Replacement Project)

WHEREAS, pursuant to RFB-2044, sealed bids were received and opened on June 21, 2018 for the HRC Building Partial Window Replacement Project (the "Project") on behalf of the Chemung County Department of Buildings and Grounds ("CCB&G"); and

WHEREAS, Foor & Associates Architects ("Foor") and the Superintendent of the CCB&G have recommended the acceptance of the lowest responsible bid meeting all bid specifications for the Project; and

WHEREAS, the County Executive and the Budget Committee have reviewed the bid specifications, the bids submitted, the recommendation of Foor and the Superintendent of the CCB&G, and they all recommend the Chemung County Legislature award the bid to the lowest responsible bidder meeting all bid specifications for the Project at a cost of \$126,000 as more particularly described in the bid submitted; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Window Specialist, Inc. is the lowest responsible bidder meeting all bid specifications for the Project; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Window Specialist, Inc. for the Project at a total cost of \$126,000 as more specifically set forth in the bid submitted by Window Specialist, Inc.; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Window Specialist, Inc. shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that this agreement shall not be renewed, the initial term thereof extended, or the agreement amended without the express consent by Resolution of this Legislature.
