RESOLUTION AWARDING BID TO W2 OPERATOR TRAINING GROUP, LLC ON  
BEHALF OF CHEMUNG COUNTY SEWER DISTRICT NO. 1  
(RFB-2050 One new and unused sludge pump)

WHEREAS, a sealed bid, pursuant to RFB-2050, was received and opened on July 12, 2018 on behalf of Chemung County Sewer District No. 1 (the "District") for the purchase of one new and unused sludge pump (the "Equipment"); and

WHEREAS, the Executive Director of the District has reviewed the bid specifications and the sole bid submitted and he recommends the acceptance of the lowest responsible bid meeting all bid specifications for the Equipment; and

WHEREAS, the County Executive and the Multi-Services Committee have reviewed the bid specifications, the bid submitted, and the recommendation of the Executive Director of the District, and they all recommend the Chemung County Legislature award the bid to W2 Operator Training Group, LLC ("W2"), their having determined that W2 is the lowest responsible bidder meeting all bid specifications for the Equipment; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that W2 is the lowest, responsible bidder meeting all bid specifications for the Equipment; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with W2 for the Equipment at a total cost of \$93,635 as more specifically set forth in the bid submitted by W2; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and W2 shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be amended without express consent by Resolution of this Legislature.
