RESOLUTION EXTENDING AGREEMENT WITH CASELLA FOR REFUSE AND
RECYCLING COLLECTION SERVICES ON BEHALF OF THE
CHEMUNG COUNTY PURCHASING DIRECTOR (RFB-1992)

WHEREAS, by Resolution No. 18-041 and RFB-1992 the County of Chemung on behalf of its Purchasing Director accepted bids and entered into an agreement with Casella for the provision of refuse and recycling collection (the "Services") through December 31, 2018; and

WHEREAS, the bid specifications and subsequent agreement provided for the extension of the agreement upon the same terms and conditions for one additional one-year period; and

WHEREAS, the Purchasing Director has requested that the agreement be extended to December 31, 2019, the one-year extension period, pursuant to the bid specifications and the agreement with Casella; and

WHEREAS, the County Executive and the Budget Committee have recommended that the Chemung County Legislature approve the extension of the original agreement; now, therefore, be it

RESOLVED, that the County Executive is hereby authorized and directed to enter into an amended agreement with Casella, the terms and conditions of the amended agreement to be subject to the review and approval of the County Attorney, to extend the original agreement through December 31, 2019 for the provision of the Services; and, be it further

RESOLVED, that the agreement shall not be renewed, the term thereof further extended, or the agreement further amended without the express consent by Resolution of this Legislature.
