RESOLUTION AWARDING BID TO KOESTER ASSOCIATES ON BEHALF OF  
CHEMUNG COUNTY SEWER DISTRICT NO. 1  
(RFB-2065 One new and unused sewage pump)

WHEREAS, sealed bids, pursuant to RFB-2065, were received and opened on October 30, 2018 for one new and unused raw sewage pump (the "Pump") on behalf of Chemung County Sewer District No. 1 (the "District"); and

WHEREAS, the Executive Director of the District has recommended the acceptance of the lowest responsible bid meeting all bid specifications for the Pump; and

WHEREAS, the County Executive and the Budget Committee have reviewed the bid specifications, the bids submitted, and the recommendation of the Executive Director of the District, and they all recommend the Chemung County Legislature award the bid to the lowest responsible bidder meeting all bid specifications for the Pump, i.e., Koester Associates ("Koester"), at a cost of \$55,099 for one Cornell 12-NNF-BF18DB as more particularly described in the bid submitted by Koester; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Koester is the lowest, responsible bidder meeting all bid specifications for the Pump; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Koester for the Pump at a total cost of \$55,099 as more specifically set forth in the bid submitted by Koester; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Koester shall be subject to the review and approval of the Attorney for the District; and, be it further

RESOLVED, that the agreement shall not be renewed, the initial term thereof extended, or the agreement amended without express consent by Resolution of this Legislature.
