RESOLUTION AWARDDING BID ON BEHALF OF THE CHEMUNG COUNTY SHERIFF
(RFB-2073 Uniforms and Footwear)

WHEREAS, sealed bids were received and opened on December 21, 2018 for the provision of uniforms and footwear on behalf of the Chemung County Sheriff; and

WHEREAS, the Sheriff has recommended the acceptance of the lowest bid meeting all of the bid specifications for uniforms and footwear; and

WHEREAS, the County Executive and the Corrections and Law Committee have reviewed the bid specifications, the various bids submitted, and the recommendation of the Sheriff and they all recommend the Chemung County Legislature award the bid to United Uniform Co., Inc. ("UCC"), the lowest responsible bidder meeting the bid specifications; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that UCC is the lowest responsible bidder meeting all bid specifications for the uniforms and footwear; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with UCC for uniforms and footwear commencing January 1, 2019 through December 31, 2020 with a one year renewal option at a cost not to exceed the bid submitted by UCC (various pricing categories, gross sum bid of \$44,020 with a bid of \$26,870 for uniforms and a bid of \$17,150 for footwear); and, be it further

RESOLVED, that the agreement shall not be renewed, the initial term thereof extended, or the agreement amended without the express consent by Resolution of this Legislature.
