DEPARTMENT OF PUBLIC WORKS (Various materials and services)

WHEREAS, sealed bids, pursuant to RFB-2077R, RFB-2086, RFB-2090, RFB-2091, RFB-2092, RFB-2093, RFB-2094, RFB-2095, RFB-2096, RFB-2100, RFB-2101, RFB-2102, RFB-2103, RFB-2104, RFB-2105, RFB-2107, RFB-2108, RFB-2109, RFB-2111, RFB-2112, RFB-2113, RFB-2114, RFB-2115, RFB-2117, RFB-2119, RFB-2121, RFB-2122, and RFB-2123 were received and opened on various dates between March 12, 2019 and April 24, 2019 for various materials and services (collectively the "Materials and Services") on behalf of the Chemung County Department of Public Works (the "DPW"); and

WHEREAS, the DPW Commissioner has recommended the acceptance of the lowest responsible bids meeting all bid specifications for the Materials and Services; and

RESOLVED, that the terms and conditions of the agreements between the County of Chemung and the Successful Vendors shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreements shall not be renewed, the initial terms thereof extended, or the agreements amended without express consent by Resolution of this Legislature.
