RESOLUTION EXTENDING AGREEMENTS FOR THE PROVISION OF CERTAIN INDUSTRIAL AND COMMERCIAL SUPPLIES ON BEHALF OF THE CHEMUNG COUNTY PURCHASING DIRECTOR

WHEREAS, by Resolution No. 15-429 and RFB-1834 the County of Chemung on behalf of its Purchasing Director accepted bids and entered into agreements with various vendors (the "Vendors") for the provision of certain industrial and commercial supplies through August 10, 2018; and

WHEREAS, the bid specifications and subsequent agreement provided for the extension of the price for two additional one-year periods; and

WHEREAS, the Purchasing Director has requested that the agreement be extended to August 10, 2019, the first one-year extension period, pursuant to the bid specifications and the agreements with the Vendors; and

WHEREAS, the County Executive and the Highway Committee have recommended that the Chemung County Legislature approve the extension of the original agreements; now, therefore, be it

RESOLVED, that the County Executive is hereby authorized and directed to enter into amended agreements with the Vendors, the terms and conditions of those amended agreements to be subject to the review and approval of the County Attorney, to extend the original agreements through August 10, 2019 for the provision of certain industrial and commercial supplies; and, be it further

RESOLVED, that the agreements shall not be renewed, the terms thereof further extended, or the agreements further amended without the express consent by Resolution of this Legislature.
