RESOLUTION RESCINDING RESOLUTION NO. 19-230 RELATIVE TO RFB-2064-R ON  
BEHALF OF THE ELMIRA CORNING REGIONAL AIRPORT  
(Interior and Exterior Cleaning of Terminal Windows)

WHEREAS, On March 11, 2019 the Chemung County Legislature, pursuant to Resolution No. 19-230, awarded the bid RFB-2064-R to Atalian Global Services (“AGS”) relative to interior and exterior cleaning of terminal windows; and

WHEREAS, the Director of the Elmira Corning Regional Airport (the “Director”) has informed this Legislature that an agreement between AGS and Chemung County was never executed due to lack of response from AGS regarding the Notice of Award or written request made by the Purchasing Department; and

WHEREAS, the Director has requested that the Chemung County Legislature rescind Resolution No. 19-230 awarding the bid RFB-2064-R to AGS, as AGS has demonstrated that it is not a “responsible bidder” under General Municipal Law §103; and

WHEREAS, the County Executive and the Aviation Committee have recommended that the Chemung County Legislature rescind Resolution No. 19-230, and declares that AGS is not a responsible bidder; now, therefore, be it

RESOLVED, that Resolution No. 19-230 be and hereby is rescinded, upon a determination that AGS is not a responsible bidder.
