RESOLUTION AWARDING BID TO SHEEN AND SHINE, INC. ON BEHALF OF THE
ELMIRA CORNING REGIONAL AIRPORT
(RFB-2064-R – interior and exterior cleaning of terminal windows)

WHEREAS, sealed bids, pursuant to RFB-2064-R, were received and opened on February 7, 2019 on behalf of the Elmira Corning Regional Airport (the “ECRA”) for interior and exterior cleaning of terminal windows (the “Services”); and

WHEREAS, the Aviation Director has reviewed the bid specifications and the bids submitted and he recommends the acceptance of the bid submitted by Sheen and Shine, Inc. as the lowest responsible bid meeting all bid specifications for the Services; and

WHEREAS, the County Executive and the Aviation Committee have reviewed the bid specifications, the bids submitted, and the recommendation of the Director of Aviation, and they all recommend the Chemung County Legislature award the bid for the Project to Sheen and Shine, Inc. having determined that Sheen and Shine, Inc. is the lowest responsible bidder meeting all bid specifications for the Services; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Sheen and Shine, Inc. is the lowest responsible bidder meeting all bid specifications for the Services; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Sheen and Shine, Inc. for interior and exterior cleaning of terminal windows at the ECRA at cost not to exceed \$13,176 annually as more specifically set forth in the bid submitted by BBP; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Sheen and Shine, Inc. shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed or that this extension term be further extended, or the agreement amended without express consent by resolution of this Legislature.
