RESOLUTION AWARDING BID TO DALRYMPLE GRAVEL & CONTRACTING COMPANY, INC. ON BEHALF OF THE CHEMUNG COUNTY DEPARTMENT OF PUBLIC WORKS (RFB-2133 Hot Mix Asphalt Pavements)

WHEREAS, sealed bids, pursuant to RFB-2133, were received and opened on May 7, 2019 on behalf of the Chemung County Department of Public Works ("CCDPW") for Hot Mix Asphalt Pavements (the "Project"); and

WHEREAS, the Commissioner of the CCDPW (the "Commissioner") has reviewed the bid specifications and the bids submitted and he recommends the acceptance of the bid submitted by Dalrymple Gravel & Contracting Company, Inc. ("Dalrymple") as the lowest responsible bid meeting all bid specifications for the Project; and

WHEREAS, the County Executive and the Highway Committee have reviewed the bid specifications, the bids submitted, and the recommendation of the Commissioner, and they all recommend the Chemung County Legislature award the bid for the Project to Dalrymple having determined that Dalrymple is the lowest responsible bidder meeting all bid specifications for the Project; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Dalrymple is the lowest responsible bidder meeting all bid specifications for the Project; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Dalrymple for the Hot Mix Asphalt Pavements at cost not to exceed \$746,741.80 as more specifically set forth in the bid submitted by Dalrymple; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Dalrymple shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed or that this extension term be further extended, or the agreement amended without express consent by resolution of this Legislature.
