RESOLUTION AWARDING BID TO HUNT ENGINEERS, ARCHITECTS, LAND SURVEYORS, AND LANDSCAPE ARCHITECTS ON BEHALF OF THE CHEMUNG COUNTY TRANSIT SYSTEM (RFQu-2120 Chemung County Transportation Center Rehabilitation Design and Construction Administration)

WHEREAS, sealed proposals, pursuant to RFQu-2120, were received and opened on, 2019 on behalf of the Chemung County Transit System for Design and Construction Administration for the Chemung County Transportation Center Rehabilitation Project (the "Project"); and

WHEREAS, the Director of the Elmira-Chemung Transportation Council (the "Director") has reviewed the proposal specifications and the proposals submitted and she recommends the acceptance of the proposal submitted by Hunt Engineers, Architects, Land Surveyors, and Landscape Architects ("Hunt") as the lowest responsible bid meeting all specifications for the Project; and

WHEREAS, the County Executive and the Multi-Services Committee have reviewed the proposal specifications, the proposals submitted, and the recommendation of the Director, and they all recommend the Chemung County Legislature award the bid for the Project to Hunt having determined that Hunt is the lowest responsible bidder meeting all specifications for the Project; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Hunt is the lowest responsible bidder meeting all specifications for the Project; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Hunt for Design and Construction Administration for the Chemung County Transportation Center Rehabilitation Project at cost not to exceed \$86,700 as more specifically set forth in the proposal submitted by Hunt; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Hunt shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed or that this extension term be further extended, or the agreement amended without express consent by resolution of this Legislature.
