**RESOLUTION AWARDING BID TO STAND ENERGY CORPORATION ON
BEHALF OF THE CHEMUNG COUNTY DIRECTOR OF BUDGET AND RESEARCH
(RFB-2129 – supply of natural gas)**

WHEREAS, sealed bids, pursuant to RFB-1929, were received and opened on May 3, 2019 for the supply of natural gas to County of Chemung facilities (the “Project”); and

WHEREAS, the Director of Budget and Research has recommended the acceptance of the lowest responsible bid meeting all bid specifications for the Project; and

WHEREAS, the County Executive and the Budget Committee have reviewed the bid specifications, the bids submitted, and the recommendation of the Director of Budget and Research, and they all recommended the Chemung County Legislature award the bid to the lowest responsible bidder meeting all bid specifications, i.e., Stand Energy for the Project; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that Stand Energy is the lowest, responsible bidder meeting all bid specifications for the Project; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with Stand Energy for the Project as more specifically set forth in the bid submitted by Stand Energy; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and Stand Energy shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed, the initial term thereof extended, or the agreement amended without express consent by Resolution of this Legislature.
