RESOLUTION AWARDED BID TO J&B INSTALLATIONS, INC. ON BEHALF OF THE CHEMUNG COUNTY DEPARTMENT OF BUILDINGS AND GROUNDS (RFB-2132 – roof replacement – Nursing Facility, Board of Elections, National Soaring Museum)

WHEREAS, sealed bids, pursuant to RFB-2132, were received and opened on May 23, 2019 on behalf of the Chemung County Department of Buildings and Grounds for Roof Replacements at the Board of Elections, Soaring Museum, and Nursing Facility for Chemung County (the “Project”); and

WHEREAS, the Acting Superintendent of the Chemung County Buildings and Grounds Department (the “Superintendent”) and Foor and Associates Architects (“FAA”) have reviewed the bid specifications and the bids submitted and they both recommend the acceptance of the bid submitted by J&B Installations, Inc.(“J&B”) as the lowest responsible bid meeting all bid specifications for the Project; and

WHEREAS, the County Executive and the Buildings and Grounds Committee have reviewed the bid specifications, the bids submitted, and the recommendation of the Superintendent and FAA, and they all recommend the Chemung County Legislature award the bid for the Project to J&B having determined that J&B is the lowest responsible bidder meeting all bid specifications for the Project; now, therefore, be it

RESOLVED, that the Chemung County Legislature does hereby find that J&B is the lowest responsible bidder meeting all bid specifications for the Project; and, be it further

RESOLVED, that the County Executive is hereby authorized and directed to enter into an agreement with J&B for Roof Replacements at the Board of Elections, Soaring Museum, and Nursing Facility for Chemung County at cost not to exceed \$492,000 as more specifically set forth in the bid submitted by J&B; and, be it further

RESOLVED, that the terms and conditions of the agreement between the County of Chemung and J&B shall be subject to the review and approval of the County Attorney; and, be it further

RESOLVED, that the agreement shall not be renewed or that this extension term be further extended, or the agreement amended without express consent by resolution of this Legislature.
