

# APPLICATION FOR SPECIAL HAULING PERMIT COUNTY HIGHWAYS AND STREETS IN CHEMUNG COUNTY

**Chemung County Special Hauling Permit:** This permit is designed to obtain permission from the Department of Public Works to complete any oversize and overweight hauling on Chemung County Roads, including travel over bridges on County and Town roads. A bond may also be required to protect against damages to County R-O-W infrastructure and appurtenances.

**Insurance requirements:** The applicant agrees in the acceptance of this permit to assume all responsibility and liability for damages to persons and/or property that may accrue during such transport through the negligence of himself, his agents or employees, or from any other cause, and to have the County of Chemung harmless there from. An insurance policy naming Chemung County and its employees as additional insured must be provided in the amount of \$1,000,000 per incident, \$2,000,000 aggregate.

Permission is hereby granted to said Owner / Applicant to complete said work in accordance with the following conditions and restrictions:

- 1) County Superintendent of Highways reserves the right to revoke or annul this permit should the applicant fail to comply with all terms and conditions.
- 2) No transport / movements will be on made Saturdays, Sundays or Holidays without express written permission of the County.
- 3) All transport / movements will be limited to 7:00 AM to 4:30 PM when weather and road conditions are deemed favorable.
- 4) This permit must be carried on the vehicle at all times.
- 5) All affected municipalities shall be notified a minimum of 24 hours prior to transport and shall be notified upon completion of such transport.
- 6) For operations which shall be conducted over a span of several days, a maintenance plan shall be submitted by the Owner / Applicant to the affected municipalities prior to transport on the affected roadways and shall be agreed to in writing by affected municipalities.
- 7) Transport and use of roads and streets shall be in accordance with the applicable specifications and requirements of each affected municipality.
- 8) A New York State Department of Transportation Special Hauling or Divisible Load Permit must be submitted with the application for this permit. A Certificate of Liability Insurance must be submitted with the application for this permit.
- 9) All vehicles shall comply with NYS DOT Permit restrictions when traveling on local roads and streets in Chemung County. All permits shall expire upon the completion of the permitted use as described herein.
- 10) All requested routes shall detour around any bridges posted for R-Permits or posted for weight limits.
- 11) It is further agreed that any and all transport / movements shall be made in the manner provided by law, and in accordance with the conditions and regulations as hereinafter set forth, all forming a part hereof in which the applicant agrees in the acceptance of this permit to assume all responsibilities and liability for damages to persons and/or property which may accrue during such transport through the negligence of the applicant, their agents or employees, or from any other cause and to have the Municipality in Chemung County harmless there from.
